**Aluminum** Components contain at least 40% pre-industrial recycling content.  
**Plastics** Components contain at least 4% post-industrial and 20% pre-industrial recycling content.  
**Steel** Components contain at least 60% post-industrial recycling content.  
**Fabrics** Fabrics are offered with up to 100% recycled polyester.  
**Wood** Components contain at least 30% pre-industrial recycling content.  
**Packing** Contains at least 80% post-industrial recycling content.  
**Notes** Kimball Office encourages recycling at the end of the products life cycle. Recycling of these materials will depend upon local programs.
